It is agreed between Seller and Buyer as follows:

1. Seller's Representations

- (a) As of this agreement, Seller agrees that Puppy is in good health at the time puppy is transferred to Buyers care. Seller will provide Buyer with information detailing treatment the puppy has received under Seller's care. Puppy is in good health and free of communicable diseases, with any exceptions noted here:
- (b) The Buyer has 72 hours to examine the puppy and have a vet examine the puppy. The puppy may be returned with all paperwork for any reason for a refund minus the non-refundable hold fee providing Buyer pays all return transportation costs. Breeder is at no point responsible for veterinary fees, costs, or diagnoses after Buyer has taken possession of Puppy.
- (c) Seller guarantees that Puppy is free of life-threatening diseases or disabilities for 72 hours after delivery to Buyer. Buyer may return the puppy to Seller for a full refund for any reason within this period minus the non-refundable hold fee,
- (d) Buyer agrees that Seller shall not be held responsible for the development of any health issues, disqualifying faults, diseases, or disorders after this time

2. Buyer's Representations

- (a) If Buyer does not return the puppy within the 72 hour time frame mentioned above then Buyer is completely satisfied with and waives any and all claims regarding the Puppy's conformation, outward appearance, and ability to breed. Buy signing the agreement Buyer agrees that Puppy meets the breed standards at this age.
- (b) Buyer agrees that No guarantees are given that puppy will be able to reproduce or qualify for showing later in life.
- (c) Buyer agrees to use the name *Jfbassets* or *Janzen's* at the beginning of the puppy's AKC registered name so that proper credit is given for our bloodlines, buyer also agrees upon purchase that Puppy will not be registered with any other registries besides the American Kennel Club without written permission from Breeder
- (d) Buyer agrees to update Seller at least once a year on condition of Puppy and results of shows; this is to include a currant, clear picture of Puppy. Updates may be sent via email, social media, or US Postal Service, to the above listed email address or postal address unless Breeder gives Buyer change of addresses, in which case will be sent to the new addresses.

4. Stipulation - Show/Breed Purchase

Buyer understands that they have purchased full AKC registration on the named puppy and agrees to use the name *Jfbassets* or *Janzen's* at the beginning of the puppy's AKC registered name. Purchasing Full registration will potentially allow buyer to breed said puppy or show in sanctioned AKC conformation shows, but it does not guarantee that your puppy will win, qualify, or reproduce. The Seller will not be responsible if puppy develops any defaults or health conditions which would preclude the showing or breeding of the puppy. This contract does not cover any disqualifying faults. Seller has agreed to grant the buyer these rights by giving full AKC registration to the buyer. These rights have been granted based on the understanding between the parties of the responsibility these rights bear.
